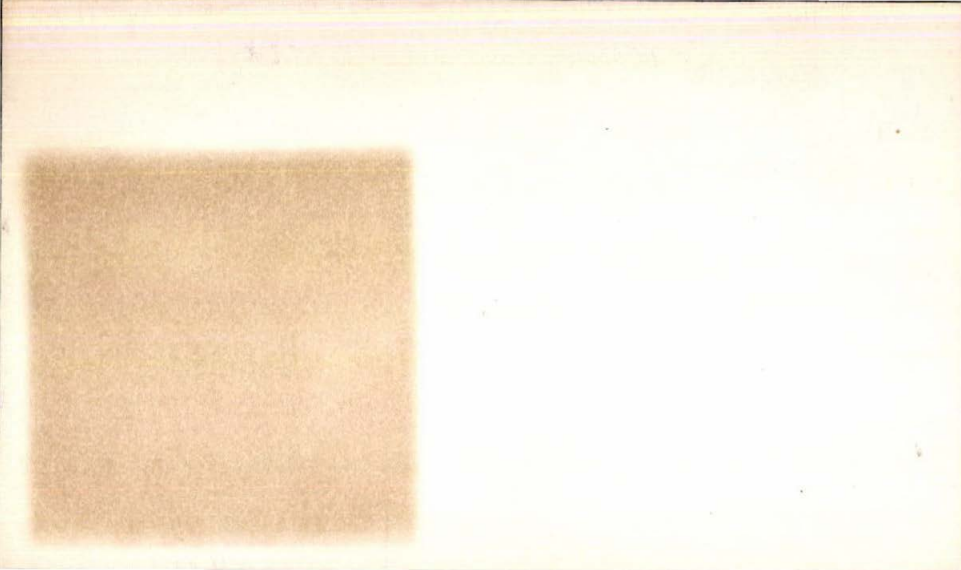

## **Arthur E. Allen** **color lab supervisor**

**SPRINGVALE** — Arthur E. Allen, 87, of Amelia Street died Monday at his home after a long illness.

He was born in Springvale, a son of Stanley B. and Maude Roberts Allen, attended Springvale schools and graduated from Sanford High School in 1925. He was a lifelong area resident and lived his entire life in only two houses.

In 1943, he was awarded the Carnegie Medal for acts of heroism. He saved Alfred Binette Jr. and Harold Pulsifer Jr. from drowning in a skating accident on Stump Pond on Dec. 4, 1943.

Mr. Allen was employed as a supervisor in the dye room at the former Goodall-Sanford Mills. When they

closed, he became the supervisor of the color lab, first for Wasco and then for the former American Cyanamid plant in Sanford, retiring in 1970.

Mr. Allen was a member and past master of the Springvale Lodge, a 32nd degree mason through the Scottish Rite in Portland, a past president of the Sanford Town Club and of the Sanford-Springvale Fish & Game Club.

He served more than 20 years with the Springvale Volunteer Fire Department, and helped fight the forest fires of 1947.

He enjoyed hunting and fishing.

His first wife, Mildred (Senior) Allen, died in 1938.

Survivors include his wife of almost 51 years, M. Edith (Leslie) Allen of Springvale; a daughter, Nancy Carlton of Shapleigh; a brother, Charles of Portland; three grandchildren and three great-grandchildren.

A funeral will be held at 1 p.m. Wednesday at the Heald Funeral Home, 61 Main St., with the Rev. Wayne Wallace of Springvale officiating. Burial will follow in Riverside Cemetery.

**SOUTH PORTLAND** — The Rev. Edward Fearebay Allen died Friday at his home.

He was born in Jonesboro, a son of the Rev. Eugene V. and Lucy Fearebay Allen, graduated from Houlton High School, attended Ricker Junior College, Houlton, for a year and earned his bachelor's degree from Brothers' College of Drew University in 1933.

He was a member of the Masons.

A daughter, Edith Bider, died in 1997. A granddaughter also died previously.

Surviving are his wife of 61 years of South Portland; a daughter, Mrs. Watson (Alayne) Walden of Falmouth; four grandsons; and seven great-grandchildren.
