

YARMOUTH—Fred O. Allen, 99, Yarmouth's oldest citizen, died yesterday in his home, 59 West Elm St.

A retired railroad man, Mr. Allen had been in failing health the past several weeks. But up until last year, he celebrated many birthdays by cutting the grass around the house with a hand scythe and chopping armfuls of firewood between greetings to well wishers.

He was the oldest member of the Knights of Pythias in Maine, becoming a charter member of Westcustogo Lodge in 1883. He was probably the oldest Mason in the state.

Surviving are a daughter, Mrs. Lucy A. Joy, with whom he made his home; two grandchildren, Mrs. Albert W. Spaulding Jr., Brentwood, N.H., and Albert A. Joy Jr., Milford, Conn.; six great-grandchildren and two nieces.

Funeral services will be at 2 p.m. tomorrow in the Lindquist Funeral Home, Yarmouth. The Rev. C. Weston Jones, pastor of the Peoples Methodist Church, Woodland, will officiate. 
Coming to Portland in 1938, he worked for Capital Motor Transportation for more than 29 years, until his retirement as manager in 1967.

Herbert I. Allen passed away Monday, Jan. 11, at his residence, 579 Congress Street, following several years of failing health.

From his position as principal of Deering High School in earlier years, his inventive genius led him into the field of electrochemistry in which he became internationally known to the scientific world as an authority in electrochemical research through his development of a pioneer electrolytic process used by the paper industry and the heavy chemical industry. He was at one time employed as consulting engineer for a local engineering firm, one notable achievement during that period being the devising and perfecting of the process for browning rifle barrels used today by the Winchester Repeating Arms Company.

He was president and treasurer of the Electron Chemical Co. and of the Allen Electrolytic Cell Corporation of this City, both of which corporations made use of his patented process for the production of chlorine and caustic soda by the electrolysis of salv. Mr. Allen was trustee of the Portland Public Library and was greatly interested in this work, giving invaluable advice relating to scientific works added to the library. Until his health prohibited it, he was an active participant in the work of the Rotary Club and to certain other groups devoted to civic improvement. He was a graduate of Harvard College, and a member of the Masonic lodge.

His spirit of friendliness and sympathetic understanding endeared him to a great number of people and the lives of those who were privileged to know him as a friend have been greatly enriched by association with him.

A sister, Mrs. James L. Tryon, formerly of this City and wife of the well known writer and educator, is Mr. Allen's nearest surviving relative
