He was born on July 31, 1915, in Saco, the son of Wallace and Agnes (Gallacher) Cunningham. Thomas is a graduate of Thornton Academy in 1934 and completed an apprenticeship program at the Saco Lowell Shops.

After completing his apprenticeship, he went on to work for many years at Saco Lowell as a mechanical engineer foreman. He owned and operated Tom's Market in Saco.

He enjoyed spending time with his family, travelling, working with his hands, and spending winters in Florida. In his earlier years, he played varsity basketball at Thornton Academy and coached basketball at the First Church of Nashua, where he was a longtime member. He was a member and Past Master of Saco Masonic Lodge #9 F&AM, and was currently the second oldest member. He was a member of the Scottish Rite and was also a past Worthy Patron for Annette Chapter Order of the Eastern Star in Saco.

Mr. Cunningham was essential in creating the New England Association for Children with Learning Disabilities and served as the chairman of the directors planning committee. This organization lead to the start of the Landmark School in Prides Crossing, Mass.

He is predeceased by his wife, Priscilla (Dennett) Cunningham; his sisters Agnes and Mary Cunningham, and his brothers, Wallace and William Cunningham. Mr. Cunningham is survived by two sons, Thomas M. Cunningham Jr. of Durham, N.H. and Carl Steven Cunningham of New Fairfield, Conn., a daughter, Priscilla Forte of Rye, N.H.; five grandchildren; four great-grandchildren; and sisters-in-law, Rena Cunningham, Marjorie Martin and Charlotte Otto.
