



## Woods Scaler's Body Found At Dead River

Dead River, July 14.—Charles Gleason, 62, of Greenville an employe of the Dead River Lumber Company for 40 years was found dead today along side of a tote road by another woodsman driving a team. The company was cutting wood in the area around Round Pond.


