Huntington's disease previously claimed the lives of one of Mr. McKenney's sons, Bruce McKenney, as well as the lives of his grandmother and an aunt.

While still healthy, Mr. McKenney had great mechanical ability, although he was more of a professional teacher than a tradesman, according to his brother.

He was a former vice president of the Industrial Arts Teachers of Maine and a past president of both the Madawaska and Portland Jaycees.

He was a member of the Harmony Masonic Lodge, Kappa Delta Phi fraternity and the USM Alumni Association.

As a teen-ager, he was active in Boy Scouts and achieved the rank of Eagle Scout.

On June 30 Arthur Blair McKown passed away after a short illness in Saint Andrews Hospital, Boothbay Harbor and services were held on July 3 at 2.00 p. m. at his home in that town.

In 1881 Mr. McKown was born in East Boothbay, the son of Capt. Samuel Fuller and Mrs. Eliza Adams McKown. He lived there during the early years of his life, attending the local schools. As a young man he came to Portland, and after graduating from business college, worked for the Eastern Steamship Company. In 1911 he became connected with the Gulf Refining Company, later the Gulf Oil Corporation, one of their first employees in New England.

The greater part of his 30 years' service was spent in Portland as agent, although he was agent at the Forest Hills Station for seven years, during which time he made his home in Milton, Mass. Lately he has spent most of his time outside, devoting his efforts to the fuel oil business.

Simple in his tastes he found a very great happiness in his home and close friendships which were priceless to him. Less than two years ago in fulfillment of a life's dream he bought a home in Boothbay Harbor, where he planned to spend his last years amid the surroundings he so loved.

Of Mr. McKown it can be truly said that he did pass away leaving the world a little better for his having lived in it and friends a little more enriched by contact with him.

He was associated with this concern for 30 years, being one of those honored on May 10, 1941, by a dinner at the Copley Plaza Hotel, Boston, attended by over 600, none with less than 10 years' service. At that time a lapel button with three diamonds was presented to him.
