### taught industrial arts at high schools

GORHAM - Peter G. McKenney, 57, an industrial arts teacher who was active in the Jaycees, died Monday in a Lewiston nursing home. Mr. McKenney had been ill for many years with Huntington's chorea, an inherited disease of the central nervous system that leads to progressive mental and physical deterioration.

Mr. McKenney was a high school industrial arts teacher for many years before his illness. After graduating in 1959 from the former Gorham State Teachers College, he taught two years at Erskine Academy, South China, and then for four years at Madawaska High School.

He taught industrial arts for 12 years at South Portland High School until ill health forced his retirement in 1977.

"He was a dedicated, professional teacher," said Arnold McKenney, his brother, who is a former director of industrial arts education in Maine. "He sort of took after me in this respect."

Arnold McKenney is nearly 20 years older than his brother.

"He worked hard with students," said Arnold McKenney. "If anyone in this world was dedicated to his teaching, he was. He was doing wonderfully well at South Portland before his health problems started."

Huntington's disease previously claimed the lives of one of Mr. McKenney's sons, Bruce McKenney, as well as the lives of his grandmother and an aunt.

While still healthy, Mr. McKenney had great mechanical ability, although he was more of a professional teacher than a tradesman, according to his brother.

He was a former vice president of the Industrial Arts Teachers of Maine and a past president of both the Madawaska and Portland Jaycees.

He was a member of the Harmony Masonic Lodge, Kappa Delta Phi fraternity and the USM Alumni Association.



As a teen-ager, he was active in Boy Scouts and achieved the rank of Eagle Scout.

In 1970 he was business manager for the Miss Maine Pageant.





Born in Portland, the son of the late Arthur B. Sr. and Annie Vickerson McKown, he attended Portland schools. graduating from Portland High School in 1937.


He was a veteran of World War II. having served in the U.S. Navy. For 20 years he was employed by the General Electric Company in Portland, retiring
