

"He was colorful, and he always had sage advice," said Norman Alterman, who is married to Karen Alterman of Scarsdale, N.Y., Mr. Moore's only surviving relative.

Born in Portland, a son of Walter DeC. Moore and Lillian B. Brown Moore, he grew up on Ashmont Street and later lived on Codman Street for many years. He was a 1924 graduate of Deering High School and also graduated from Silver Bay School in New York.
