His family came to Bangor in search of new business opportunities, settling in this city in the early 1900s. Mr. Paul began his retail career in Bangor in 1918, working long hours ofter school at Bangar High so that he could earn enough money to go to college. He attended both the University of Maine and Columbia University, After completing one semester at Columbia, he was called home because his father, John Paul, was in ill health. At the age of 20, he assumed responsibility as head of his family, taking care of his widowed mother, brother and three young sisters. 

Mr. Payant was a member of Hiram Lodge, AF & AM, and a 32nd degree Mason.


