LINCOLNVILLE and WASHINGTON. "PA. - Cmdr. Frank Chase Perry, U.S.N., Lincolnville's most decorated serviceman in World War II, died May 18, 1993, at the Washington Hospital. Returning to Lincolnville for several months, Perry was raised in King David's Lodge, AF & AM and became a charter member of the local VFW post. At Purdue University in 1962, he earned a master's degree in mathematics, fitting him for his second career, teaching that subject at Washington and Jefferson College for 15 years. His Rotary membership, commenced in the Camden club, was extended in the Washington club. There he served on the East Washington Borough Council: was a vestryman and former worden of the Trinity Episcopal Church; and enjoyed the Reserve Retired Officers Group. Surviv-
