



Plummer Rites Wednesday


Funeral services for Frank E. Plummer, nearly 74, will be held at 2 p. m. Wednesday in his home at 1 Burnham Street, South Portland, where he died suddenly Monday morning of a heart attack. Interment will be in Laurel Hill Cemetery, Saco. Mr. Plummer had been in excellent health.

He was born Aug. 13, 1861, at Saco and as a boy moved to Kennebunk, where he learned the carpenter trade and carried on an extensive contracting business for a number of years before coming to this vicinity, For 36 years he carried on the business here. The past year he had been janitor of the Summer Street schoolhouse.

Mr. Plummer married Miss Abble S. Kimball at Kennebunk Thanksgiving Day, 1883, and they celebrated their 50th wedding anniversary in 1933. He was the oldest member of the Masonic Lodge at Kennebunk.

SKOWHEGAN, June 26-George H. Plummer, 66, Skowhegan insurance man, and identified for many years with the promotion of Somerset Central Agricultural Society and its successor, Skowhegan State Fair, died today at the Waterville Osteopathic Hospital. He was born in Madison. son of Charles A. and Carrie Rutherford Plummer. The family moved to Skowhegan and he was graduated from Skowhegan High School in 1899. In 1910 he became a partner of Herbert Wentworth in the insurance firm of Wentworth and Plummer, and after, Mr. Wentworth's death remained with the son, G. Allan Wentworth,

Earlier in life, Mr. Plummer had been connected with a heating and plumbing business. He was a past commander of De Molay Commandery, KT, and held offices in Somerset Lodge, AF&AM, Somerset Chapter, RAN, and Mt. Moriah Council, R and SM.

He had served as president of Skowhegan Fair and for a long period was its secretary, and afterward was prominent in its councils. He had also been an officer of the Maine State Fairs Association.

He was first chairman of Somerset County Selective Service Board.

He was married Sept. 14, 1910, to Miss Maude Thompson of Skowhegan, who survives, as does one son, Richard Alden Plummer, who is connected with the Skowhegan office staff of the Waterville Morning Sentinel; and a sister, Mrs. Roy Sylvester, Mt. Pleasant Avenue, Skowhegan, and several cousins.
