# Rockport PD Chief Perley Sprague

LINCOLNVILLE — Perley Morrison Sprague, 48, died Nov. 15, 1996, after suffering a heart attack while on duty as police chief for the town of Rockport.

Born in Bangor April 1, 1948, he was the son of Clayton and Arline (Morrison) Sprague.

He served with the Coast Guard in Vietnam, and was a member of the Portland Police Department before going to work for the Maine Department of Marine Resources. He retired there after 21 years, as chief of the Bureau of Marine Patrol.

A security manager at MBNA in Orono for two years, he was hired as Rockport police chief in 1995.

Mr. Sprague was a member of Bayshore Baptist Church, the American Legion in Camden, and Camden Lodge of Masons, and was a certified member of the Maine Chief of Police Association.



Surviving are his wife Jill (Steeves) Sprague of Lincolnville; daughter Erin E. Leonard of Lincolnville; his mother of Bangor; two brothers, Clayton Sprague of Rockport and Michael Sprague of Boston; sister Patricia Sprague of Bangor; several aunts, uncles, nieces, nephews and cousins. His father died in 1990.

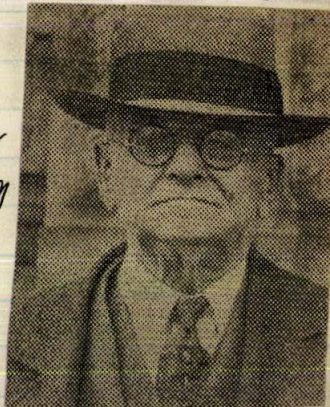

Deputy Sheriff Fred W. Spring, 90, of 86 Saco Street, Westbrook, former street railway man and believed the oldest deputy sheriff in the State, died this morning in a Portland hospital. His 15 years service as a deputy included about eight years as Cumberland County jury officer here.

He was born at Hiram Aug. 14, 1853. He began his railroad service with the Maine Central Railroad. He afterwards served as

conductor on the street car lines of the Portland Railroad Company until 1891 when he supervised the construction of the Westbrook division of the railroad in its horse car period and after it was electrified and continued in this position until he retired in 1924 after 33 years continuous employment. For a time after leaving the railroad, he served as clerk at the Columbia Hotel in this City.

## WESLEY SPRINGER

ST. ALBANS, Sept. 18—Wesley Springer, 63, died early Saturday morning in his automobile at the H. C. Baxter & Bro. canning plant in Hartland where he was employed.

His wife, Mrs. Eva Springer, employed at the same factory, found her husband apparently asleep in the car when she completed her work at about 1 a.m. Saturday.

She drove to their home here and, when she was unable to arouse her husband, called her son, Victor, who resides at home. Dr. P. R. Briggs, Hartland, was summoned and reported Mr. Springer had died at about 12:30. Death was attributed to a heart ailment.
