MECHANIC FALLS — Alfred M. Thurlow, Jr., 62, died early Thursday morning at Stephens Memorial Hospital, Norway, following a brief illness.

He was born in Poland Feb. 20, 1922, the son of Alfred M. and Gladys Chipman Thurlow. He was a graduate of Mechanic Falls High School and had been employed as a radio technician for WMTW-TV. He was also instrumental in setting up a radio station in Rockland. He was a member of the Advent Christian Church and Tyrian Lodge, AF&AM. For six years he was pastor of the Oxford Advent Curch and had been pastor of the West Auburn Advent Church for ten years. He was an Air Force veteran of World War II. He married Hazel Austin on April 6, 1946.

He is survived by his wife; a daughter, Mrs. Thelma Kilbreth and two grandsons, all of Mechanic Falls. A son, Forrest Thurlow, predeceased him.

PHILLIPS - Dr. Charles E. Thurlow

died Wednesday, Feb. 4, 2004 at home Phillips.

Dr. Thurlow was born Nov. 7. 1911, at Bumham Jct. in the home of his paternal grandparents. He was the son of Dr. Norman C. Thurlow and Anna

Thurlow. Martin His parents made their first home in Portland moving to Fryeburg when Charles was four years old, Charles was the eldest of four children. He attended public schools and graduated from Fryeburg Academy in the Class of 1929. He took his pre-med courses at Bowdoin College, and received the degree of Doctor of Dental Medicine from Tufts University in 1935.

On June 30 of that year, he married Myrtle Alice Brown of Bartlett, N. H. Dr. Samuel Elliot performed the ceremony in the Arlington Street Church in Boston, Mass. That same year, Dr. Thurlow became associated with Dr. Rupert Stratton of Rockland. At that time he served offices in Rockland, Vinalhaven, and the State rison at Thomaston. On Sept. 1; 1936 he established a practice in Phillips, Maine where he remained

active until 1989. Dr. Thurlow brought the first X-Ray machine to Franklin County. He performed X-Ray diagnosis for many of the area physicians and he was a member of the Staff at Franklin Memorial Hospital. Dr. Thurlow initiated the first Dental Head Start Program in the country, and in 1976 he was recognized for this achievement.

Dr. Thurlow devised and made in his laboratory obturators (a prosthetic device replacing the lost tissue in the oral cavity after surgical removal of tumors). He invented a way to make the appliance hollow, thus reducing the weight. One of his more significant achievements was restoring 85% of the maxilla ina woman who had had a tumor

He was a quiet, home-loving man, an avid fisherman, well known in his ental practice and for his humerous and spicy stories.

In addition to a very busy practice, Dr. Thurlow found time for many civic projects. He served as Chairman of the Town Committee for the Republican Party, acted as chair of the committee to rebuild the town after the business section of Phillips was destroyed by fire, and he served as President of the P.T.A. and was a member of the Elementary School **Building Committee.**

Dr. Thurlow was a life member of the Maine Dental Association, the American Dental Association, Pythagorean #11 Masonic Lodge at Fryeburg, The first Congregational Church of Fryeburg, and Alpha Tau

Omega Fratemity.

He is survived by his wife of 68 years; a son, Norman C. Thurlow II and his wife, Judith Nottage of Hampden; three daughters, Susan Spencer Gagne and her husband, loseph of Bethlehem, Conn., Margeret Richman and her husband, Richard of Metamora, III., and Melissa Yerxa of lonesboro; ten grandchildreh; and four great - grandchildren.

Charles was predeceased by his parents, his brothers, John and William, and a sister, Elizabeth.

Funeral services will be held Wednesday Feb. 11, at 1 p.m. at the Phillips United Methodist Church, interment in the family lot in Fryeburg, at a later date. Friends wishing may make donations in his memory to:
