His enrollment in Anah Temple was recorded as June 18, 1960.



Joshua Treat II. Civic Leader. Dies In Belfast

WINTERPORT, Oct. 13—Joshua Treat II, business and civic leader here and a descendent of one of New England's oldest families, died at Waldo County Hospital, Belfast, today after a long illness. He was 75.

He was the father of New Hampshire Republican State Chairman, Judge William W. Treat.

He managed the Treat Agency, dealing in insurance and real estate throughout eastern Maine, and was president and a director of Perry's Inc., a corporation with retail stores.

Born in Winterport in 1881, son of Joshua and Annie Treat.

Born in Winterport in 1881, son of Joshua and Annie Treat, he was a great-great-grandson of Joshua Treat, II, first settler of the Penobscot Bay region and of Robert Treat, colonial governor of Connecticut. His grandfather, Col. William Treat operated Treat & Co., 19th century shipbuilders with yards in Winterport and Frankfort.

For many years Mr. Treat operated Treat & Lowe, a mens' clothing store which was later merged into Treat's Department Store. He was also owner of the Rexall Store here until 1949 and for a number of years was proprietor of the Winterport Manufacturing Co., producing men's shirts and other garments.

Mr. Treat was a trustee and long active in the affairs of the Winterport Methodist Church. He was a member of the Lions Club and was a charter member of Howard Lodge No. 69, AF& AM, and of Garfield Lodge of Odd Fellows. He was presented with 50-year membership medals in both organizations in recent

in both organizations in recent

years.
Surviving are his widow, Clara A. Treat; two sons, Judge Treat of Hampton, N.H. and Joshua Treat III of Belfast; a daughter, Mrs. Donald S. Clark Jr., of Tucson, Ariz., and a sister, Mrs. Elizabeth T. Nash of Winterport, and seven grandchildren.
Funeral services will be at 2 p.m. Monday at the Winterport Methodist Church, with interment in the Treat lot, Oak Hill Cemetery. years.
